Should be given to the student within one month of the date on which the student has demonstrated the knowledge and skills needed to complete a qualification or qualification unit set as an objective in the personal competence development plan.

Personal competence development plan

1. The personal competence development plan prepared for me enabled me to progress flexibly in my studies.

Explanation: When planning the studies, choices can be made that help the student embark on their career plans immediately after completing a qualification or a unit.
