Processing applicant data

This privacy statement explains how we process personal data. This statement tells you, the data subject, how we process your personal data and what your rights are and how you can exercise them. The processing of personal data refers to activities concerning the personal data of natural persons, e.g. you, and datasets containing personal data. 6. Personal data disclosure and publication

In manual processing, data security is ensured as follows:
